



# Navigating the PPWR and EPR laws with Tosca's reusable plastic packaging



## Introduction

The newly adopted Packaging and Packaging Waste Regulation (PPWR) and rapidly evolving Extended Producer Responsibility (EPR) laws are radically transforming packaging systems. This guide outlines how to easily adapt through reusable plastic packaging.



### What is the PPWR?

The PPWR, entered into force on February 11<sup>th</sup> 2025 as part of the European Green Deal and replaces the former Packaging and Packing Waste Directive with stricter, EU-wide rules to cut excess packaging, boost reuse, promote recycled material, and increase the recycling of packaging waste.

Based on circular economy principles, the PPWR promotes reuse for the first time, redressing the fact that recycling has been the historical go to for waste reduction. Reusable packaging is also a stronger means in cutting pollution and driving overall positive environmental change.

## Extended Producer Responsibility (EPR)

The PPWR implements the requirements for EPR, which makes producers and users financially responsible for packaging from creation to disposal, driving waste reduction and sustainability. In the UK, EPR fees are currently still applied to reusable packaging systems, but we are working with DEFRA to minimise those fees and ensure reusable solutions are promoted above single use. With Tosca's reusable packaging lasting **for up to 100 uses before being recycled**, you pay a fee just once—compared to paying 30 to 100 times for the same amount of single-use packaging!

## Understanding Packaging

Packaging falls into three categories: **primary** (direct product encasement), **secondary** (protective transport packaging), and **tertiary** (bulk transport). The PPWR and EPR laws impact each differently, but are geared to driving a shift from single-use to reusable options—making reusable secondary and tertiary packaging, such as RPCs, plastic pallets, and bulk containers ideal solutions.

# Reusable Packaging Supports PPWR and EPR Compliance

These new regulations aims to standardise packaging waste management across the EU through setting mandatory targets.



## Reduction targets for a circular economy

The PPWR sets reduction targets for packaging waste: **5% by 2030, 10% by 2035, and 15% by 2040.**

**Implications for businesses:** Businesses must **transition from single-use packaging to sustainable alternatives**, such as reusable plastic crates and bulk containers.



## Reuse and reusable packaging targets

The PPWR sets reuse targets of **40% by 2030 and 70% by 2040** for certain packaging types, including transport, sales and grouped packaging. This legislation is significant as it is the first to explicitly mention **“reuse”**.

**Implications for businesses:** While cardboard is exempt, reusable packaging such as plastic pallets and foldable containers will be increasingly necessary in order to achieve those targets. Along with reusable plastic crates they also **significantly reduce environmental impact cutting water use by >30% and greenhouse gas emissions by >20%.**



## Recycled and recyclable content

The PPWR mandates recycled content targets and criteria to improve recyclability. By 2030, non-PET food packaging must have 10% recycled content, **rising to 25% by 2040** while non-food contact packaging must have 35% and 65% recycled content by those respective dates.

**Implications for businesses:** Many reusable secondary and tertiary packaging options **already exceed 30%**, ensuring compliance.

EPR and any associated fees are currently being implemented differently across Member States and by the UK. This makes it confusing and costly when single-use packaging is involved.
